

PETITION FOR CONTEST OF CANDIDACY

COMES NOW LESLIE KATHRYN OSBORN, Candidate for the Office of State Labor Commissioner, having lawfully filed a Declaration of Candidacy during the filing period held on April 13-15, 2022, hereby contests the candidacy of Sean the Patriot Roberts [hereinafter referred to as "Contestee"] for the same office, pursuant to 6 O.S. 2011, § 5-118 of the Oklahoma Statutes, and as a basis for this contest, states and alleges as follows:

1. Contestee's Declaration of Candidacy (See Attachment A) indicates that he wishes to be shown on the ballot as Sean the Patriot Roberts. 6 O.S. 2011, §5-111A -1 provides the following direction regarding this condition of a valid declaration of candidacy:

"The *name* (emphasis added) of the candidate as it shall appear on the ballot."

2. Okla. Admin. Code 230:20-3-38 (a) Candidates Name provides the following guidance regarding the above:

"(a) The candidate's name shall appear on the ballot exactly as it appears on the designated line of the Candidate Information and Oath. *A candidate who is generally known by or who does business using* (emphasis added) a nickname, birth name, or any name other than his or her legal name may choose to appear on the ballot by providing that name on the designated line of the Candidate Information and Oath for."

3. There is no evidence that Contestee "is generally known by or who does business using" the name Sean the Patriot Roberts. In fact, Contestee has appeared on the ballot in seven successive legislative elections as Kevin Sean Roberts or Sean Roberts. The FEC filing in the congressional race he abruptly abandoned last week reflects his candidate name as 'Kevin Sean Roberts' and his campaign committee as "Patriots for Sean Roberts." See Attachment B.
4. A search of the business entity records in the office of the Oklahoma Secretary of State reflects that Sean the Patriot Roberts is not a registered entity. See Attachment C.
5. Section 8 of the Declaration of Candidacy (See Attachment A) contains the following Oath and Notarization:


"I, the undersigned, swear and affirm that the information provided in this Declaration of Candidacy...is true and correct..."

6. Contestee's representation that he is generally known as "Sean the Patriot Roberts" is not true and correct.
7. The use of the term "the Patriot" between Contestee's first and last name is nothing less than a cynical artifice to attempt to misdirect or mislead voters as to the Contestee's credentials for office. In fact, "the Patriot" is in actuality a campaign slogan as evidenced by the Contestee's campaign material (See Attachment D) and use of the term "Patriots for Sean Roberts" for his federal campaign committee.

WHEREFORE, Petitioner Leslie Kathryn Osborn requests that the State Election Board strike the candidacy of Contestee and order his name not be placed on the ballot for the reasons set forth above.


